Are there services covered before you meet your deductible?	Yes. Benefits available with no charge such as <u>Network Preventive care</u> services are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes.

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
